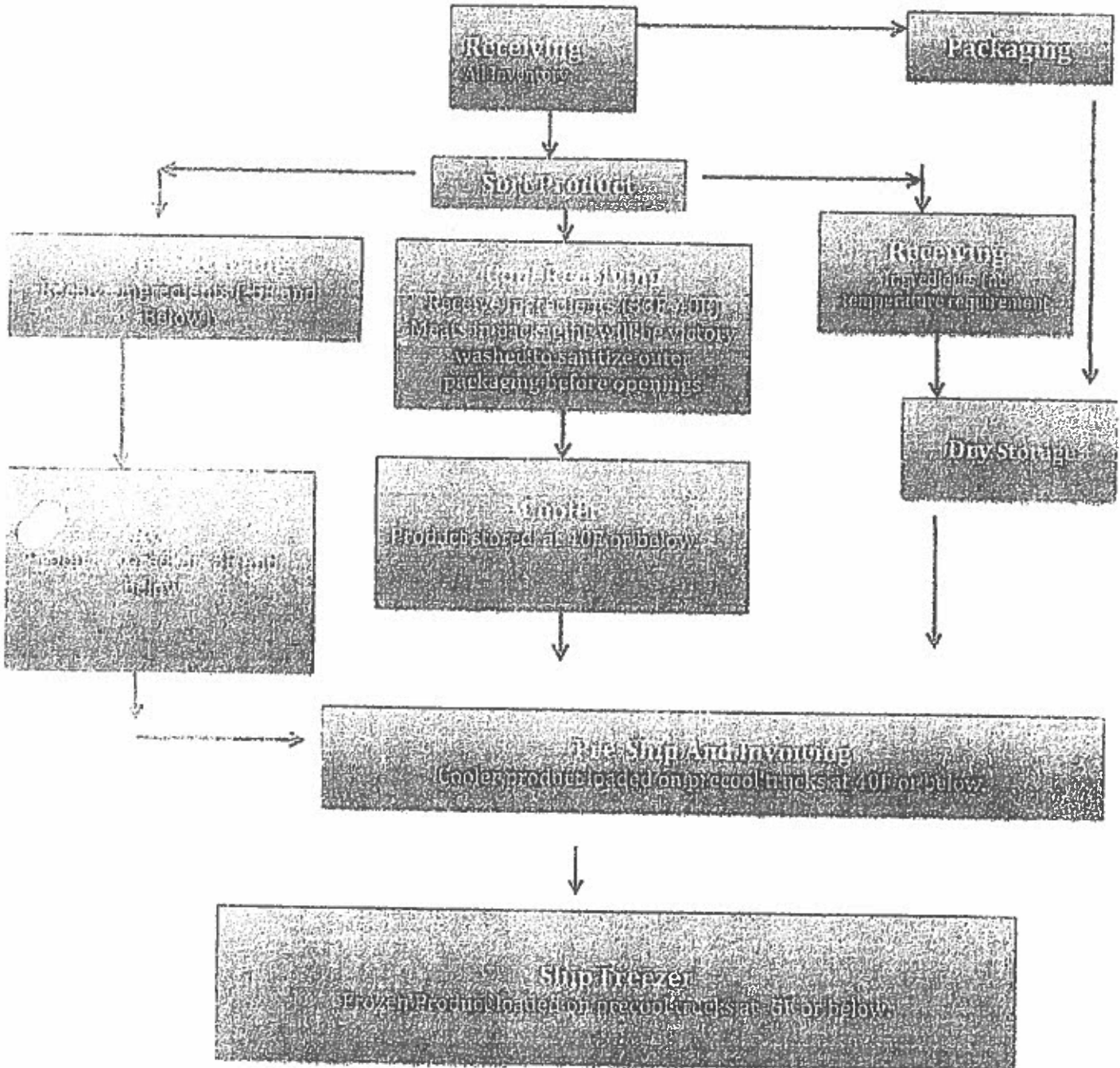
1. Foreign Objects

Procedure to Control Hazards

1. All products must be visually inspected for foreign objects during the receiving and selection of the products.
2. All product must be visually inspected for damage before receiving the product from the manufacturer and selection of order to customers.
3. Temperature in the freezer and cooler are monitored. All the delivery trucks will be pre-cooled before order for delivery will be loaded into trucks.

In case of any deviation in the product during this process, the product will not be received or shipped and will be placed in the designated area for damaged product and will be reviewed by the warehouse manager to determine if the product must be "destroyed".
